Each of Mr. Wu, Ms. Wong, Mr. Lui and Mr. Zhang is a director of Victory Stand.

Note 2: These 82,500,000 Shares are held by Dragon Flame Holdings Limited ("Dragon Flame"). Mr. Pan Chik ("Mr. Pan") beneficially owns 100% of the issued share capital of Dragon Flame.
